Located in the 'Desinganadu 'Chathannur belongs to the Cashew Capital of the World, Kollam. Sree Narayana College, Chathannur is an esteemed educational institution spread across a 28-acre land area is 3kms away from the National highway. This prestigious Aided College is affiliated to the University of Kerala and is managed by Sree Narayana Trust Kollam. Bearing in letter and spirit the lofty ideals of the Guru, this institution of higher learning established on 31 August 1981 under the

Sree Narayana Trusts, Kollam, has been imparting knowledge to the entire society, with the vision of

“Liberation through Education”. The legacy of the institution flourished along the years with the increase in demand for higher education facilities for children in the rural suburbs of Chathannur.
